Topics of Discussion:

Budget (presented by Jodi Pugsley on behalf of Will Wolff):

- 1. Notice from the state 501C3 needs to be paid and renewed.
- 2. Balance sheet:

- 3. Proposed new HOA Fiscal Year = February 1 to January 31. With dues due on January 1 with a late fee if not paid by January 31st.
- 4. Present dues = \$401.01. Proposed new dues = \$463.00. The \$2417 short fall was divided among the 39 houses for a total of \$61.97 per house then that was added to present due amount.
- 5. Future concerns not covered in current dues.
 - a. Rent for a hall to hold HOA meetings. Approx. \$300-600 per use
 - b. Office supplies (printer cartridges, stamps, envelopes, etc.)
 - c. Fixing the irrigation system near the front of the neighborhood
 - d. Irregular electric bills, may need repair on lighting or pumps.

- 6. Discussed the use of a National HOA that we could access form letters and advice on how to handles problems. Cost = \$200/yr.
- 7. Connie Berner has volunteered to be on the HOA ACC committee
- 8. Kevin Bowen is setting up a community neighborhood email.
- 9. Insurance policy for the association and board members thru Wakefield Insurance. Need a copy of the policy.
- 10. Ideas shared: private plowing for the subdivision and to have the road graded. To be discussed at future Board meetings.
- 11. FYI: If you need to call 911, give them directions to your house. It has taken them up to 45 minutes to find the subdivision in the past.
- 12. Pond/Light maintenance team formed: Craig Cox, Terry Waller, Ted House, Jeff Lippert, and Doug Pugsley. Named the "WPS"
- 13. HOA to contact Whitfield
- 14. Becky Fox to contact State Farm for an insurance quote.
- 15. Vote taken at end of meeting to gage approval for increasing the dues. All 15 in attendance approve. Need 24 of the 39 households to pass the increase. Board members to meet with neighbors not in attendance to get more votes.
