- iv) Question from floor as to why the assessment increase Response:
  - (1) Primary reason is work party turn out has gone down and increased the need to have necessary work done by professionals
- v) The waterfall repair expense was from 2017 and not counted in 2018 budget. Therefore, some of the amount don't appear to balance if just looking at 2018 numbers.
